WRITING YOUR WILL

A Will is one of the simplest ways to safeguard the future of your family and friends. It is the best way to ensure that your wishes are followed and can help to reduce the worry for your loved ones at a very stressful time. After you've taken care of the people closest to you, a small gift in your Will could make a huge difference.

We strongly recommend that you consult a solicitor or STEP (Society of Trust and Estate Practitioners) qualified Will-writer when you make your will, to ensure it is accurate and reflects your wishes.

As a legal document, your Will should be prepared professionally. It is advisable to have an up-to-date Will and to review it every few years and after any major changes in your life, such as marriage, divorce or births of children or grandchildren.

To save time with your solicitor, you can make a list of all your assets, including any savings, investments and your possessions to help you work out the value of your estate. Then consider who you want to benefit from your estate.

Most people want to make sure their family are looked after and then consider leaving a gift to a favourite charity, such as FSDP. To further save time, it would also be useful to take the charity's address and registered charity number as seen in our suggested wording.

If you have already written your Will and wish to make a simple amendment, you can make a Codicil. This is an appendix to your existing Will which must be witnessed in exactly the same way and kept with the original.

If you have already chosen to leave us a gift in your Will, we would like to take the opportunity to thank you for thinking of the FSDP. Please complete a [Legacy Pledge form](#) and return it to us.

All bequests should be left to Flying Scholarships for Disabled People and must state our registered charity number 1148914, together with our registered address: Flying Scholarships for Disabled People, Douglas Bader House, Horcott Hill, Fairford, Gloucestershire, GL7 4RB.

There are two types of bequest that can be made.

Pecuniary Bequest

A gift of a fixed sum of money in your Will is called a pecuniary bequest. The value of pecuniary legacies will decrease over time, as the cost of living increases.

Residuary Bequest

A gift of the remainder of the estate after all other bequests have been made and debts cleared is called a residuary bequest.

Either bequest can be made for general charitable purposes or with an expression of wish eg. to specifically go towards a Scholarship.

Recommended wording in your Will

1 Pecuniary Bequests – for general charitable purposes

I give the sum of pounds to Flying Scholarships for Disabled People (Registered Charity No:1148914) of Douglas Bader House, Horcott Hill, Fairford, Gloucestershire, GL7 4RB absolutely for its general charitable purposes and the receipt of the Treasurer or other proper officer for the time being of Flying Scholarships for Disabled People shall be a complete discharge to my executors.

If at my death any charity named as a beneficiary in this Will or any Codicil hereto has changed its name or amalgamated with or transferred its assets to another body then my Executors shall give effect to any gift made to such charity as if it had been made (in the first case) to the body in its changed name or (in the second place) to the body which results from such amalgamation or to which such transfer has been made.

2 Pecuniary Bequests – with an expression of wish

I give the sum of pounds to Flying Scholarships for Disabled People (Registered Charity No:1148914) of Douglas Bader House, Horcott Hill, Fairford, Gloucestershire, GL7 4RB absolutely and I request Flying Scholarships for Disabled People but without imposing and binding trust or legal obligation to use the legacy forand the receipt of the Treasurer or other proper officer for the time being of Flying Scholarships for Disabled People shall be a complete discharge to my executors.

3 Residuary Bequests – for general charitable purposes

LEGACY CODICIL

If you have already made a Will and would like to add a gift, here is an example of a codicil which is an appendix to a Will. This is a legal document which needs to be completed in the same way as your original Will, particularly with regard to signing and witnessing. When you have completed your codicil, please ensure that it is stored together with your original Will.
